

Conference Presenters

Kirk Watson, former mayor of Austin, Texas, has worked as a lawyer, mediator and public affairs consultant. Known for his unifying leadership and he is currently Chair-elect of the Greater Austin Chamber of Commerce. Among Mr. Watson's awards and recognitions are The International Downtown Association's Individual Achievement and Impact Awards, honorary membership in the Texas Society of Architects, the GACC's "Austinite of the Year" and the Texas Nature Conservancy Leadership Award. He was named the Outstanding Young Lawyer of Texas and received the Sierra Club, Lone Star Chapter, Special Award for his service as Chair of the Texas Air Control Board. Mr. Watson was named best mayor in Texas for business by Texas Monthly Biz.

Bryan Lambeth, PE is the Unit Leader for the Meteorology and Continuous Air Monitoring Systems Validation Team at the TCEQ. He has previously worked for the Texas Air Control Board Meteorology Group and at Radian Corporation as an air quality meteorologist. He is a registered Professional Engineer in the State of Texas. Mr. Lambeth received a Bachelors Degree in Engineering Science and a Masters Degree in Engineering from the University of Texas at Austin, with a Major in Meteorology and a Minor in Environmental Health Engineering.

Pam Giblin is senior partner with Baker Botts and heads the firm's environmental practice group. She is listed in the Environmental Law section of The Best Lawyers in America. Ms. Giblin served as General Counsel of the Texas Air Control Board and was the first Chair of the City of Austin's Commission on Electric Rates. For the State Bar of Texas, she has served on the Board of Directors of the Environmental Law Section and as Chair of the Administrative Law Committee and Vice-Chair of the Public Law Section. Ms. Giblin received both her B.A., with honors, and her J.D. from the University of Texas. Ms. Giblin is certified in Administrative Law by the Texas Board of Legal Specialization.

Robert Nolan is currently an environmental advisor for ExxonMobil's Safety, Health and Environment Department, where hew works with national trade associations on federal air issues. Mr. Nolan has worked for over 20 years as a technologist and supervisor at ExxonMobil. He worked closely with the TCEQ and regional stakeholders to develop the State Implementation Plan for the Houston-Galveston region. Mr. Nolan has served as Chair of the Council of Government's Regional Air Quality Planning Committee and the Greater Houston Partnership's Clean Air Committee. He has also served on the Executive Committee of TCEQ's Science Coordinating Committee and Advisory Council for the Texas Environmental Research Consortium.

Gregg A. Cooke is "Of Counsel" with Guida, Slavich & Flores, P.C. and is a Principal with Global Environment and Technology Foundation. Mr. Cooke was formerly the Region VI Administrator for the EPA. He developed innovative clean air plans, for both Dallas-Fort Worth and Houston-Galveston and the "early action compact" concept, being adopted by Austin and San Antonio. Mr. Cooke has served on the Board of Directors and as General Counsel of the Border Environmental Cooperation Commission, which provides funding for environmental infrastructure projects., practiced environmental law as a Haynes and Boone partner; and served as Chief of the Natural Resource Protection and Energy Division for the Texas Attorney General. While with the AG, he served as the state's North America Free Trade Agreement Environmental Liaison. Mr. Cooke has earned a B.A. and J.D. from Baylor and an M.S. from the University of Virginia.

Ramón Alvarez, Ph.D. is a scientist for Environmental Defense, where he promotes the attainment of air quality standards. He currently serves on the Pollution Prevention Advisory Committee of the TCEQ, and various technical advisory committees on air quality issues around the state. He has also worked with industries on the US-Mexico border to find cost-effective methods of reducing waste and pollution. He has also served on the Editorial Board of Environmental Engineering Science, the Board of Directors of the Texas Center for Policy Studies, and the Environmental Board of the City of Austin. Dr. Alvarez obtained a B.S. from Duke University and a Ph.D. in physical chemistry from the University of California at Berkeley. At UC Berkeley he was a National Science Foundation Predoctoral Fellow and a lecturer in Environmental Chemistry.

Beverly S. Silas is the Executive Director of the Envision Central Texas project. Beverly was elected to the Austin Community College Board of Trustees in 1998 and has also served in leadership roles with Leadership Texas; Leadership Austin; Downtown Austin Alliance; Association of Community College Trustees; Austin Area Urban League and WorkSource-Austin Area Workforce Development Board of Directors. Ms. Silas was previously employed with Southwestern Bell. She received a Governor's Award as an Outstanding Texas Volunteer in 1993 and the Award of Merit from the National Women of Achievement in 2002. She is a graduate of Huston-Tillotson College with a Bachelor's degree in Public Management.

Fred Blood is the Sustainability Officer of the City of Austin. He coordinates regional ground-level ozone efforts, environmentally preferred purchasing, resource conservation, high-performance building initiatives, and similar sustainable initiatives. Mr. Blood is an environmental toxicologist with expertise in toxic materials in the built environment, including indoor air quality, lead, asbestos and environmental site assessments. He has managed and/or worked on large multi-disciplinary studies ranging from environmental impact studies for coal mines and synthetic fuel plants to environmental assessments of Superfund hazardous waste sites.

Craig D. Pedersen is the Texas Water Resource leader for URS Corporation. He was formerly Chief Executive Officer of the Texas Water Development Board. He authored or was a key participant in the 2002 Texas State Water Plan and in four previous Texas State Water Plans. He helped draft water planning and infrastructure financing legislation at the state and federal levels, including the 1997 omnibus water legislation, numerous Texas constitutional amendments, and the statutes to create a Texas disadvantaged communities (e.g. colonias) program. Mr. Pedersen also has extensive knowledge of inter-state, national, and international water issues and infrastructure finance and development (i.e. Rio Grande Compact). He has chaired a major committee of the Council of Infrastructure Finance Authorities and has participated in the Western States Water Council.

Lisa Hatzenbuehler is manager of water resource protection for the LCRA, where she is responsible for implementing water quality protection, monitoring and assessment programs, as well as water quality education programs. LCRA's water quality programs have been recognized by the EPA as a "Clean Water Partner for the 21st Century" and its educational "The Colorado River Basin Poster" won first place at the 13th Annual Texas GIS Forum and Training Conference. Ms. Hatzenbuehler has made many presentations on water quality to LCRA's Highland Lakes constituency, as well as to many international audiences. She is a graduate of Southwest Texas State University (now Texas State University) with an M.S. in Environmental Law and B.S. in Education.

Pat Murphy is currently Environmental Officer for the City of Austin's Watershed Protection and Development Review Department, where he is responsible for working with City management, elected officials, and citizens to balance environmental issues against other public policy issues. He has served as Assistant City Arborist and worked in all areas of environmental development regulations. Mr. Murphy Mr. Murphy received a B.S. in Forest Wildlife Management from Stephen F. Austin State University and pursued graduate studies there in Forest Resource Management.

Brigid Shea currently heads Shea and Associates, an environmental and policy consulting business. Ms. Shea is a former Austin City Councilwoman. She was a co-founder of the Save Our Springs Alliance and was the former head of that organization. Ms. Shea attended Yale Divinity School on a Rockefeller Foundation Fellowship.

Michael Daniels, PE works in the Edwards Aquifer Protection Program for the Texas Commission on Environmental Quality Austin Regional Office as an environmental investigator. He previously worked as an environmental engineer, facilities engineer, and research engineer. Mr. Daniels has a degree in chemical engineering.

Ben Milford, PG is an Environmental Investigator in the Edwards Aquifer Protection Program at the Texas Commission on Environmental Quality. His environmental experience began with the Texas Department of Health. He has been with the TCEQ Austin Region since 1992. Mr. Milford is a Certified Professional Geologist and obtained a Bachelor of Science degree with a major in geology at Midwestern State University in Wichita Falls, Texas.
