Watch)....
The HOA is looking for neighbors that would like to participate in the upcoming National Night Out Aug 5th that will take place on Chimney Hills Drive. The purpose of NNO is to:

- Heighten crime and drug prevention awareness.
- Generate support and participation in crime efforts
- Strengthen neighborhood spirit and police community relations
- Send a message to criminals letting them know that neighborhoods are organized and fighting back

The Association would like to see this extended into a year round neighborhood watch program.

In recent weeks and months a few of our neighbors on Edenbourgh and Wellesley have experienced vehicle break-ins. If you know of other thefts, please let your HOA know so that we can convey this to other neighbors to be on the lookout for suspicious activity. Increased surveillance can happen if a "close patrol" is requested by the person filing a report or by anyone suspecting problems. When the patrols are made and how often will vary.

Residents leaving for out of town can also request this. All neighbors must help monitor our area and report the details to our HOA once they have phoned the Sheriff's Dept. The Sheriff's Dept may follow up as needed. **Do not wait to be a victim.** 

For **non-emergencies**, call the **Travis Co. Sheriff** dispatch directly at **854-9285**. Calling **311** is a delay since we are in the **ETJ** and cannot use APD. If you call **311**, you will either be asked to phone the sheriff's office or be transferred. It is better to just call the dispatch yourself.

Encourage your neighbors to phone **WHENEVER** they suspect or witness a crime immediately. Reports must be made for any property damage, theft, gang related behavior, drug dealing, etc.

If you should find mail that has been placed in your mailbox by mistake you should do the following:

- DO NOT Hand deliver
- Stand up the letter, etc on its edge and place letter to the back of your box

ater Pressure.... Several neighbors are having problems with their water heaters and in ground water pipes. (A couple of neighbors have reported that they had to have their water heaters replaced) The suspected cause is high water pressure. There was a letter that came out a couple of weeks ago from the City of Austin addressing the issue of high water pressure (If any one has a copy of that letter, could I please get a copy). The City is/was working on a water pump station and work wasn't completed resulting in high water pressure in this area. This high water pressure is causing the water pressure regulators installed near our individual water meters to fail, thereby causing apparent damage to pipes and some home water heaters. If anyone you are having similar problems or know of someone else in the neighborhood that is, please report it to the association at the contact info number listed at the end of this newsletter.

If your trees or plants are growing over onto someone else's property, please practice common courtesy and trim them to avoid any conflicts with your neighbor.

reen Belt and Homeowner's Property....

This item has been brought up once before and obviously needs to be repeated often. The Greenbelt is property owned by the City of Austin and IS NOT to be used as a playground or for any other purposes. It is a protected area, as is the creek that runs through the greenbelt. Homeowners that back up to the greenbelt are not supposed to mow in the greenbelt area. So your children should not be playing there as per the City of Austin ordinance. They also should not be cutting across or going through neighbors back yards unless given permission. There was an incident where two young boys came into a neighbors yard from the greenbelt, passed through the gate (they left the gate open) and proceeded on about their business. Unless you feel its okay for other people to come in to or on your property, the children should be told not to play in the greenbelt and to cross a neighbor's property unless given permission. Due to a rash of vehicle break-ins; for all we know they are casing people's home to break in to them at a later time. A neighbor has reported seeing coyotes at night and there are rattlesnakes in the area. So keep your children safe and explain to them about other people's property. Again this is only about neighbor consideration and common courtesy.

The association is seeking bid proposals and design ideas to build a kiosk or a bulletin board with cover at the mailboxes. The kiosk/bulletin board will be used to post notices about events happening in the neighborhood. It would also be used to post handbills, garage sale notices, etc. Please send email to the HOA contact info number listed at the end of this newsletter. If there is a vehicle, trailer, etc that appears to be abandoned let the association know so that the vehicle or trailer can be tagged and removed. Just a reminder boats and trailers are not to be parked on the street as per our Deed Restrictions. Homeowners in violation will receive form letters requesting that they remove said vehicle or trailer.
