YOUR HOME OWNERS ASSOCIATION.....

As neighbors we should all show respect for each other. As we are not fortunate to have an area in the subdivision where the children can play safely, it is understandable that they will play where they can. However, they need to show respect and consideration for neighbors. They may not realize that their playing may be disturbing others. Another concern is the safety of the children as cars pass by. I have heard from



several neighbors who have said that as they pass through, that the

children are very hesitant in making a path for the cars to pass safely. The **deed restrictions** state that basketball goals and backboards may be placed in the driveway as long as they are not installed closer to the front or side lot lines than the applicable building set back line. In other words, the basketball goals and backboards are to be placed in the driveway so the driveway becomes the court which would keep the children safely off the street.

Please tell the children to be very careful as they play in the neighborhood, but also respect neighbors whose homes they play near.

ticketed. Please be considerate of your neighbors and keep the noise levels to a dull roar.

About 33% of you have sent in your dues that are owed. Another notice of dues owed will be going out shortly. There will be one more notice after that. For those dues that remain uncollected the



homeowners association will take

steps to place liens on homes to collect what is owed. Placing Liens on homes by the association is addressed in Section 3.6, page 6 of the Amended and Supplemental Declaration of Covenants, Conditions and Restrictions for Chimney Hills North. In a nutshell, the association has the right to do so, provided the conditions of Section 3.5 are met, (e.g. the association was formed legally with a 51% vote of individual homeowners declaring the association is a valid entity.) This was done in 1996. Copies of the above were supposed to be in your paperwork when you closed on your home. Copies of the deed restriction, by-laws, and incorporation papers are available upon request. There is a \$5 copy fee.
