## Trash Can Reminder from the ACC

There are certain rules and restrictions that govern the use and care of our properties. Just a reminder that garbage cans must be out of site (for example, behind a fence or in your garage). So, as a reminder to many of you and an introduction to those who are new to Cypress Mill...

-Keep garbage cans out of public view.
-Boats, campers, trailers, and/or commercial vehicles are not permitted in driveways or the street.
-Posting commercial or personal business signs is not permitted.
-Construction of patio covers, rooms, storage sheds, large playground equipment, basketball goals, or fences must have prior approval from the Architectural Control Committee.

One of the commitments you made when you agreed to buy, or rent, a home in Cypress Mill is to abide by these rules and restrictions. They are designed to preserve the integrity and safety of your home, as well as the entire neighborhood. They enhance the value of your home should you go to sell or rent it. (Visit the CMNA website or contact your title company for a copy of your deed restrictions.)

The Cypress Mill deed restrictions created the Cypress Mill Architectural Control Committee (CMACC) to enforce its restrictions. Its members have a strong commitment to resolve chronic violations. Please respond promptly if you are issued a violation notice.
